Today's Outlook:

Government Bonds

Speculation of Accelerated Tapering Off Hits SUN Market. The Fed officially announced a gradual tapering off policy, starting at the end of this month. The current value of quantitative easing is USD 120 billion, and if done in stages it will take 8 months to zero, or end in June 2022. On the other hand, the Fed's Board of Governors calls for accelerating tapering off so that it can end April 2022, which could then raise interest rates in 2Q22.

Corporate Bonds

PNM Repays IDR 904.8 Billion Bonds. PT Permodalan Nasional Madani stated the readiness of funds to pay off the principal of the Shelf-Registered Bonds III Phase IV Year 2020 Series A of IDR 904.8 billion. The bonds will mature on December 14, 2021. PNM has several options to pay the bonds. Meanwhile, the company's cash and cash equivalent position as of October 31, 2021 was around IDR 3 trillion. Domestic Issue

Foreign Loan Withdrawal Reaches IDR 47.3 trillion. The Directorate General of Financing and Risk Management (DJPPR) of the Ministry of Finance (Kemenkeu) reported that until the end of October 2021, the withdrawal of government foreign loans had reached IDR 47.3 trillion. Most of the debt withdrawals are low-interest loan withdrawals from multilateral and bilateral institutions to support handling the impact of Covid-19 and national economic recovery. (Kontan)

Recommendation

Fed Meeting Minutes. The release of the minutes of the Fed's meeting showed some of the central bank's officials supported an early rate hike. Currently, market participants are watching whether inflation, which continues to hold at high levels, will prompt other major central banks, including the Fed, to raise interest rates sooner than planned.
