Today's Outlook:

Government Bonds

Attractive Yields Drive Buying Action. A number of market participants took selective buying, amid rising 10-year US Treasury yields, which broke the 1.5% level. The movement of the Government Bond (SUN) market yesterday was also supported by positive sentiment the Consumer Confidence Index (IKK) for the November 2021 period rose to a level of 118.5. This indicates strong consumer confidence in the domestic economy.

Corporate Bonds

SSIA: Aim for 50% Revenue Increase. PT Surya Semesta Internusa Tbk. (SSIA) targets revenues to increase by 30% - 50% in 2022. The company also hopes that the bottom line will return to positive, along with better industry prospects. SSIA targets land sales in Subang Smartpolitan to reach 40-60 hectares, and land in Suryacipta City of Industry Karawang is targeted to sell for 20 hectares. (Bisnis Indonesia)

Domestic Issue

IDR 1,000 Trillion Translucent Tax Revenue. The Directorate General (Directorate General) of Taxes of the Ministry of Finance (Kemenkeu) reported that the realization of tax revenues until the end of November 2021 was IDR 1,082.56 trillion. This figure is equivalent to 88.04% of this year's target of IDR 1,229.6 trillion. This means that this December, the tax authorities only need to collect the remaining tax revenue of IDR 147.04 trillion in order to achieve the target that has been set. (Kontan)

Recommendation

Investors Pay Attention to External Data. Market participants will pay close attention to the release of US inflation data for the period of November; with consensus projection at 6.8% yoy. On the other hand, the weekly jobless claims figure fell to 184K, which is the lowest level in 52 years.
