# **Morning Brief**



#### Today's Outlook:

**Wall Street Vs. Main Street.** Investors are focused on retail stocks, a benchmark for consumer confidence, as high inflation and rising interest rates heavily weigh Main Street while also overshadowing Black Friday sales. Wall Street Friday, which lasted a short time after the Thanksgiving holiday, closed mixed. If this year's Black Friday is impacted by economic pressures, means that it doesn't bode well for the rest of the holiday period, which is crucial for the retail sector.

**November turned the inflation back.** The lack of sentiment in today's domestic and global economic data made investors immediately anticipate the November manufacturing and inflation data released on Thursday. Based on a Bloomberg survey, CPI Headline Indonesia in Nov. on a monthly basis is projected to record an inflation rate of 0.14% MoM, compared to Oct., which recorded a deflation rate of 0.11% MoM, in line with the increase in several food commodities, ranging from chicken eggs to rice. Amid a number of sentiments, NHKSI Research projects JCI to move sideways at the beginning of

#### CAMP : Expand Distribution Network in 2023

PT Campina Ice Cream Tbk (CAMP) confirmed that the company is next year and will again complement a load efficiency strategy to maintain net profit growth up to the end of 3Q22. Additionally, the company in 2023 will expand its distribution network to secondary and tertiary cities, which will give the company more customers

#### BBRI : Plans to Release MTN

PT Bank Rakyat Indonesia (Persero) Tbk (BBRO) plans to issue medium-term notes (MTN) without a public offering of IDR400 billion, with an interest rate ranging from 6.6%-6.98% per year. It is planned that the MTN will be distributed (Emission Date) on November 24, 2022, so that the first interest payment will be carried out on February 24, 2022. (Emiten News)

#### JAYA : Achieved IDR4.33 Billion Profit

PT Armada Berjaya Trans Tbk (JAYA), as of September 30, 2022, earned a net profit of IDR4.33 billion or a slight increase of 9% YoY. Moreover, revenue was recorded at IDR58,94 billion, up by 12% YoY, while gross profit was recorded at IDR17.55 billion or grew 10% YoY. (Emiten News)

#### 0.18% Inflation Occured in the Fourth Week of Nevember

Based on the Bank Indonesia (BI) price monitoring survey in the fourth week of November 2022, inflation in November 2022 is estimated at 0.18% MoM. Additionally, a number of primary commodities contributing to inflation in November 2022 range from purebred chicken eggs to filtered clove cigarettes and rice. (Kontan)

## **Black Friday Online Sales to Hit Record**

U.S. online spending is expected to set a record for Black Friday, according to Adobe Analytics, as steep discounts lured consumers against the backdrop of high inflation, kicking off the year's biggest shopping event on a strong note. Initial numbers from Adobe Analytics, the data and insights arm of software company Adobe Inc, showed shoppers are expected to spend between USD 9 Billion and USD 9.2 billion online on Friday, topping its forecast for a modest 1% rise to USD 9 billion.
